1.	<b>What is the eligibility criteria for admission for B. Pharmacy courses?</b>	<p><b>Maharashtra MH State Candidature candidate -</b></p> <p>1) The candidate should be Indian national 2) Passed HSC examination with at least 45% marks (at least 40% marks, in case of Backward class categories, Economically Weaker Section and Persons with Disability candidates belonging to Maharashtra State only) with Physics &amp; Chemistry and as compulsory subject along with Mathematics, Biology. 3) The Candidate should have appeared in all the subjects in MHT-CET 2021 and should obtain non zero score in MHT-CET 2021.</p> <p><b>All India Candidature Candidates.</b></p> <p>1) Same as Above, also should obtain non zero positive score in NEET OR should have appeared in all the subjects in MHT-CET 2021 and should obtain non zero score in MHT-CET 2021.</p> <p><b>NRI/OCI/PRO, Children of Indian Workers in Gulf countries, Foreign nationals-</b></p> <p>1) Passed HSC examination with at least 45% marks (at least 40% marks, in case of Backward class categories, Economically Weaker Section and Persons with Disability candidates belonging to Maharashtra State only) with Physics &amp; Chemistry and as compulsory subject along with Mathematics or Biology or both. 2) Any other criteria declared from time to time by the appropriate authority as defined under the rule.</p>
2.	<b>How to Add HSC re-evaluation Marks?</b>	Candidate can select HSC Passing Year 2021 Re-evaluation option and Fill Manually Correct marks and then Resubmit it.
<b>FAQs Related to Certificates Required</b>		

1.	<b>Which certificate is required for admission through Orphan quota?</b>	Candidate shall submit "Orphan Certificate" while confirmation of application at Facilitation Centre (FC). Refer Pro forma – U given on page number 69 of Information Brochure.
2.	<b>Which certificate is required for admission as a Person with disabilities?</b>	Certificate of Disability in the Proforma-F/F1/F2/F3/F4 as applicable. PWD should be more than 40%
3.	<b>Which certificate is required for admission as a TFWS candidate?</b>	Income Certificate of Financial year 2021-22 issued by competent authority stating that candidate's <b>parents' annual income from all sources does not Exceed Rs. 8 Lakhs.</b>
4.	<b>Which certificate is required for admission through Economically Weaker Section (EWS) quota?</b>	Candidate shall upload "Economically Weaker Certificate" while confirmation of application at Scrutiny Centre (SC). Refer Pro forma – V given on Page number 70 of Information Brochure.
5.	<b>What is NCL/CVC/EWS Receipt?</b>	NCL/CVC/EWS receipt are using when candidate has applied for NCL/CVC/EWS Certificate and at present they have receipt copy
<b>FAQs related to e-SC with e-scrutiny</b>		
1.	<b>What is Scrutiny Center (SC) with e-scrutiny?</b>	In Scrutiny Center (SC) with e-scrutiny, Candidate will able to upload all the documents online and get e-scrutiny by e-SC officer. Also he can raise the e-grievance to resolve all such discrepancy during the document verification till last date of Application Submission. The Application shall be scrutinized online and confirmed by e-SC Officer.
2.	<b>If Candidate selects the mode of verification as in e scrutiny through their login, is it mandatory to visit FC for document verification?</b>	No. The candidate no needs to visit FC if they select e scrutiny mode. Candidate will have to upload all their documents and e-SC shall electronically verify Candidate's information and uploaded document remotely.
3.	<b>If Candidate selects the mode of verification as in-person scrutiny through their login, it is mandatory to visit FC for document verification?</b>	There is no in-person scrutiny feature in the application.

4.	<b>Is it safe to select e-SC mode?</b>	Yes, it is completely safe. If any e-SC is not responding or not working, in such cases, all the application forms will be distributed other e-SC. Distribution of all such application forms will be on the basis of FIFO (first in, First out). However if any application has been in open status even also it will moved to other e-SC also new application or current application forms will be allot to the said e-SC as per CET Rule to keep of minimum application form allotment.
5.	<b>How do I know if my form has gone to SC verification?</b>	Once the Application form is opened by the e-SC for e-verification and confirmation, the form will be auto locked and the candidate will not be allow to make any changes on his/her application form. Also in Acknowledgement slip it is mentioned the allotted SC detail.
6.	<b>If candidate selects the mode with e-Scrutiny, can he go to SC and fill the Application form?</b>	If candidate selects the e-scrutiny mode, candidate will have to fill the complete application form and then candidate will be assigned e-SC for e-scrutiny.
7.	<b>What will happen if my application inopen status and e-SC is not working/ responding?</b>	If any application has been in open status even also it will moved to other e-SC center.
8.	<b>What is the process of e-scrutiny?</b>	If candidate selects the e-scrutiny mode, candidate will have to fill the complete application form and then candidate will be assigned to e-SC for e-scrutiny.
9.	<b>If any discrepancy found in my application, will I be allocated to samee-SC or different one ?</b>	If any discrepancy found by candidate during the grievance period, candidate should allot the same e-SC to edit the application form.
10.	<b>When will I be able to changes in myapplication-form in e-SC ?</b>	Once request approved by the e-SC, application form will be unlock and candidate can make all the desired changes into the form requested while submitting the grievances.
11.	<b>What will happen with my application once I made the changes and submittedit ?</b>	The same form will re-submitted to the e-SC, e-SC will check and verify the validity of the changes made by the candidate in the application form and if found correct will re confirm the application form. If any invalidity come across in the application form e-FC will convert the candidate to his previous version.

12.	<b>Can candidate make changes in application form once the form confirmed ?</b>	Once candidate application form confirmation done by e-SC. If candidate wants to make any changes to the confirm application form, the candidate will send grievance request to the e-SC for unlocking the application form. After verifying the reasons of grievances submitted by the candidates the e-SC will approve or reject the request send by the candidate.
13.	<b>How to solve if any complex discrepancy found in application form?</b>	Any complex discrepancy can be solved over the Phone call or through Messaging system.
14.	<b>How to Add HSC re-evaluation Marks ?</b>	Candidate can select HSC Passing Year 2021 Re-evaluation option and Fill Manually Correct marks and then Resubmit it.
15.	<b>After Submit the Application form whatis will next ?</b>	After successfully submission of Application Form, it will Sent to SC for E-Verification (E-Scrutiny). Please wait your application will be verification shortly.
16.	<b>How to Un-lock Application form ?</b>	If the Application form not picked by e-SC, Candidate can click on "Un-Lock Application Form for E Verification" from menu and open the application form.
17.	<b>Can I upload the Xerox copy of the documents while filling the Application Form ?</b>	No, You should upload the original documents copy only. Even colour Xerox is not allowed. This is over all responsibility of the Candidate.
18.	<b>Can I able to Crop the uploaded JPEG file if required ?</b>	Yes, You can Crop your JPEG file as and when required.
19.	<b>Can I able to capture my documents through Mobile Camera and Upload while filling the Application Form ?</b>	Yes, You can Capture your required documents and upload the same while filling the Application.
20.	<b>What are the Mandate Documents to fill the Application Form ? What if Mandate document found discrepancy ?</b>	Mandate documents are Nationality, SSC & HSC/Diploma Passed Certificate. If found discrepancy, Candidate form will be reverted back to the candidate login, and SMS will be sent to the respective candidate.
21.	<b>What if Candidate wrongly fetched the CET Exam data ?</b>	Candidate form will be reverted back to the candidate login, and SMS will be sent to the respective candidate.
22.	<b>What If Nationality, Gender wrong, Candidature Type have Discrepancy, SSC Marks mismatch, HSC Marks mismatch, JEE (Main) 2021 Paper-1 and NEET Details wrong / mismatch, CET Exam discrepancy, Photo mismatch with given gender ?</b>	Candidate form will be reverted back to the candidate login, and SMS message will be sent to the respective candidate.

23.	<b>Which Scrutiny Center Allotment will be for J&amp;K, NRI, PIO, OCI Candidate's Application Form</b>	Engineering - SP College & Pharmacy – Bombay Pharmacy College
24.	<b>What if Category candidate found discrepancy ( CVC / TVC / NCL / EWS / Open-PH) ?</b>	If Candidate will not fulfill the eligibility for Category for Open Category than such Candidate form will be revert back to the candidate login, and SMS message will be sent to the respective candidate.

1.	<b>What is last date to upload the Receipt of CVC/TVC/NCL/EWS ?</b>	Candidate shall upload the receipt of NCL/CVC/EWS while filling the application form. However the respective certificate should upload till 1st CAP round.
